**ADMISSION REQUIREMENTS**

Applicants must have:

- Completed an accredited undergraduate program in the U.S. or its equivalent;
- Demonstrated academic achievement in an appropriate discipline; and
- Completed introductory graduate courses in environmental health and biostatistics (or the equivalent) as prerequisites.

Applicants must submit:

- Application for Admission;
- Official Transcripts of all prior work;
- Letter of Intent, including statement of purpose for application to the program;
- Two (2) Letters of Recommendation; and
- Application Fee.

International applicants must submit:

- TOEFL scores and WES evaluations.

Note: If undergraduate GPA is less than 2.86, the GRE may be required.



The 15-Credit Environmental and Occupational Health Certificate enables business students to understand the basic principles of exposure science, toxicology and health outcomes affected by business practices. This knowledge will enhance interactions with government

and regulatory agencies, advocacy groups, labor unions and affected communities, and facilitate implementation of informed, scientifically sound decisions that improve community and occupational health. The certificate will provide a competitive edge to those who want to work for environmentally conscious business sectors and/or companies.

**WHY SHOULD BUSINESS LEADERS BE INTERESTED IN ENVIRONMENTAL AND OCCUPATIONAL HEALTH?**

As the world becomes increasingly aware of environmental and health impacts of manufacturing, transportation, and disposal of products used in daily life, there is a growing need for a new cadre business leaders, managers, developers, negotiators, and marketing experts with knowledge of environmental sustainability and health. Companies also want to use environmental consciousness and sustainability as marketing tools.

**PROGRAM DESIGN**

The schedule for completing the Environmental and Occupational Health Certificate is flexible. You can complete the program in two-three semesters, if desired, or you can plan a schedule for completing the five courses over a two-year period (the maximum timeframe.) The late afternoon/evening schedule and online course offerings make it convenient to continue working or gain experience while earning your Environmental and Occupational Health Certificate. The Certificate courses may also be applied toward an MPH at the Rutgers School of Public Health depending on the concentration. (Certificate holders must still apply and be admitted to the MPH program.)
