ADMISSION REQUIREMENTS

Applicants must have:

- Completed an accredited undergraduate program in the U.S. or its equivalent;
- Demonstrated academic achievement in an appropriate discipline; and
- Academic credentials at least equivalent to those required for the MPH program.

Applicants must submit:

- Application for Admission;
- Official Transcripts of all prior work;
- Scores from the Graduate Record Examination (GRE) or its equivalent (MCAT or GMAT);
- Letter of Intent, including statement of purpose for application to the program;
- Two (2) Letters of Recommendation; and
- Application Fee.

International applicants must submit:

- TOEFL scores and WES evaluations.



The 15-Credit Health Policy Certificate can help you better understand the structure and financing of the United States health system and the social and economic factors underlying population health. The certificate also will provide information on recent health care reforms, the policy and economic issues likely to affect the practice of medicine, and ongoing concerns related to access, cost and quality of care.

THE HEALTH POLICY CERTIFICATE IS INTENDED FOR:

- ▶ Medical and other health professional students;
- ▶ Those working in the pharmaceutical industry;
- ▶ Those working in local and state departments of health; and
- ▶ Those working health care settings.

PROGRAM DESIGN

The schedule for completing the Health Policy Certificate is flexible. You can complete the program in only two semesters, if desired, or you can plan a schedule for completing the five courses over a two-year period (the maximum timeframe.) The late afternoon/evening schedule and select online course offerings make it convenient to continue working or gain experience while earning your Health Policy Certificate. The Certificate courses may also be applied toward an MPH at the Rutgers School of Public Health depending on the concentration. (Certificate holders must still apply and be admitted to the MPH program.)

COST

Tuition is governed by Rutgers University and is subject to change annually. Please visit sph.rutgers.edu/admissions to confirm current tuition rates and fees.
