ADMISSION REQUIREMENTS

Applicants must have:

- Completed an accredited undergraduate program in the U.S. or its equivalent;
- Demonstrated academic achievement in an appropriate discipline; and
- Completed introductory graduate courses in environmental health and biostatistics (or the equivalent) as prerequisites.

Applicants must submit:

- Application for Admission;
- Official Transcripts of all prior work;
- Letter of Intent, including statement of purpose for application to the program;
- Two (2) Letters of Recommendation; and
- Application Fee.

International applicants must submit:

- TOEFL scores and WES evaluations.

Note: If undergraduate GPA is less than 2.86, the GRE may be required.



The 15-Credit Environmental and Occupational Health Certificate can help you advance your knowledge and skills to address major environmental and occupational health issues facing public health professionals today. Courses explore principles of toxicology, sources of environmental agents, their distribution in various environments, risk assessment methods and workplace health hazards.

PROGRAM DESIGN

You can complete the Environmental and Occupational Health Certificate in two-three semesters or you can plan a schedule for completing the courses over a two-year period (maximum timeframe.) The late afternoon/evening schedule makes it convenient to continue working or gain experience while earning your Environmental and Occupational Health Certificate. The Certificate courses may also be applied toward a degree at the Rutgers School of Public Health depending on the degree program and concentration. (Certificate holders must apply and be admitted to the degree program.)

COST
