Trainings start at 9:00am in 2019-2020 school year and finish between 3-3:30pm.

"Federal Wage & Hour & Child Labor Laws" course is only offered online; see details below.

A. OSHA 10+ (normally two day in-person training, likely to be offered virtually during summer 2020) This course has a mandatory online introduction. After you register online, an email will be sent approximately two weeks prior to the start of the course with additional information about the online portion. The online portion is the NJDOE 2-hour Safety and Health overview for 2.0 PDUs. This should be completed the week before the in-person class and no later than the week after the in-person course. Certificates and blue cards will not be mailed until requirements of this course have been completed, and payment is received.

B. Designing & Implementing Student Training Plans (normally three day in-person training, likely to be offered virtually during summer 2020)

This course includes two in-person meeting days with a site visit day in-between. The 1st and 3rd days are at the location you register for and the 2nd day is off-site to allow flexibility in conducting required field visit(s) and preparing for group discussion. For the site visit day, you can contact NJDOE staff by email or phone to arrange a specific time period to talk with their SLE consultants.

C. New Jersey Wage & Hour/Child Labor Laws (normally one day in-person training, likely to be offered virtually during summer 2020)

## III. New: American Federation of Teachers (AFT) Plan to Reopening Schools

The American Federation of Teachers (AFT) has released a plan that outlines a path to safely reopen schools and other institutions crucial to the well-being of our communities. The detailed plan includes maintaining physical distancing until the number of new cases declines for at least 14 consecutive days, providing infrastructure for testing, ensuring worker involvement in reopening plans, providing public health tools to prevent the virus from spreading, and investing in recovery.

### IV. New: Federal Guidance on Reducing Workplace Risk Exposure

The U.S. Department of Labor's Occupational Safety and Health Administration (OSHA) has issued a new poster outlining steps federal and private sector workplaces in NJ can implement to reduce the risk of exposure to the coronavirus.

The poster highlights 10 different infection prevention measures every employer can take to protect employees' safety and health during the coronavirus pandemic. Safety measures include encouraging sick workers to stay home; establishing flexible worksites and staggered work shifts; discouraging workers from using phones, desks and other work equipment and tools primarily used by other workers; and using U.S. Environmental Protection Agency-approved cleaning and disinfecting chemicals with label claims against the coronavirus.

Retail food stores, restaurants, and food pick-up/delivery are continuing to provide services during the COVID-19 pandemic. The U.S. Food and Drug Administration (FDA) has released suggested best practices, also provided as infographics in a number of languages, to help protect the safety and health of employees and consumers. National Autism Awareness month was April 2020. In recognition of, and as a follow-up to Autism Awareness month, Scott Michael Robertson, Policy Advisor on the U.S. Department of Labor's Office of Disability Employment (ODEP) Employment-Related Supports Policy Team, wrote a blog on "Employment Resources for People on the Autism Spectrum." Robertson examines how the disruption in the routines of daily life because of the COVID-19

pandemic can have a disproportionate impact on youth and adults on the autism spectrum, who may now not be able to access any, or sufficient, supports and services. # B. Structured Learning Experience Frequently Asked Questions (NJ Safe Schools website)

We have a frequently asked question (FAQ) section on the NJ Safe Schools website. There are over 50 FAQs on the list covering a range of topics in four subcategories pertaining to structured learning experiences (SLEs). Questions about SLE supervision eligibility, SLE program set-up, worksite placement considerations, required paperwork and on-site workplace concerns for students in SLEs are included. The list of FAQs was compiled from actual questions submitted by NJ teachers/supervisors. **C. NJ Safe Schools Manual** is annually updated to reflect the latest changes to both federal and/or State of NJ codes pertaining to the National Fire Protection Agency and National Electrical Code, Hazard Communication Standard, etc. The Manual includes a collection of self-inspection checklists covering environmental, health and safety regulations for secondary occupational and career orientation programs in New Jersey public schools and private schools for the disabled. The entire Manual is available to access online and as an app (see below), and meets Accessibility Guidelines.
