A.) Teacher/Supervisor Trainings:

Special Opportunity! During 2021-222 School Year, for teachers who are new to career and technical education: Work-Based Learning Supervision Training Application

The NJ Safe Schools Program (NJSS) is implementing a special grant funded initiative in partnership with the NJ Department of Education-Office of Career Readiness. The goal is to provide teachers free work-based learning (WBL or formerly school-sponsored structured learning experiences) supervisory trainings for career and technical education (CTE) and WBL in non-hazardous occupations throughout NJ via targeted recruitment.

Teachers will represent the State of NJ, with equal opportunity by region (north, central, and south) and additional opportunity for teachers in larger urban/suburban populations serving historically underrepresented minority, low-middle income students. *Eligible teachers are endorsed (certification credentials) in CTE, agricultural education, business, and/or family and consumer sciences. This application is only available for those individuals that hold a NJ teacher certificate and a NJ CTE endorsement.*

There will be six cohorts of trainings available between fall 2021 and summer 2022. Participants are selected and assigned to cohorts #1-6 using application form via PsychData. At this time, you must rank cohorts #4-6 among your "top 3".

Please note: If you previously completed the four required courses for WBL, formerly school-sponsored structured learning experiences (SLE), then you do not need to retake these courses in this capacity. If you apply and are not eligible for this opportunity, NJSS will contact you and provide more information to register for our regular work-based learning training cohorts, held through July 2022 and again in early fall 2022, at reduced total cost and an improved administrative process.

An outline of the four required courses for work-based learning supervision is below. The teachers eligible for the aforementioned opportunity are also required to take two other online topical courses—otherwise offered for free to teachers and students statewide—on apprenticeships and cyber-safety/cyber-security.

A. Federal Wage & Hour and Child Labor Laws

B.) Registration Open for 2022 Regular Schedule of Trainings for Supervising Students in Work-Based Learning

The regular schedule for work-based learning (WBL), formerly known as structured learning experiences or SLE) trainings for certified teachers only who are applying for a cooperative education coordinator certificatehazardous occupations, a cooperative education coordinator certificate, or who are appointed to coordinate WBL placements has been released.

Six cohorts will be available for registration, with the first cohort beginning January 2022 and the last cohort ending in October 2022. You must complete the four paid, required work-based learning online courses during the selected cohort's time period. All trainings will be online, with asynchronous and synchronous parts to each of the four required WBL trainings.

For 2022, the topical free courses for students (and teachers) are not reportable in NJ SMART towards graduation requirements, neither within career awareness nor career exploration; in 2020-2021 school year and fall 2021 of current school year (to 12/17/2021), career exploration had been approved.

For 2022, however, we encourage teachers and students to take advantage of these asynchronous, free, ~1.5-3-hour opportunities to augment in-person class and other online activities with your students. They can help meet curricular planning and implementation goals approved by district and school(s). Upon completing online courses, students and teachers will receive a certification of completion for each course. Also, teachers will receive professional development units (PDU).

B.) New: Spring 2022 Cohort: Enrollment in Online NJ Employment Certificates Issuing Officer Course

The New Jersey Department of Education (NJDOE), in collaboration with the New Jersey Department of Labor and Workforce Development's (NJLWD) Division of Wage and Hour Compliance and the New Jersey Safe Schools Program (NJSS), are offering an online asynchronous version of the formerly in-person training on employment certificates for issuing officers on the Rutgers Canvas Learning Management System or LMS.

The training sessions are for school officials who are designated by their local district board of education to issue A300 Combined Certification and A310 Combined Certification forms for minors under the age of 18 who work in New Jersey in accordance with Child Labor Laws and Regulations, *N.J.S.A.* 34:2-21.1 et seq. These forms are commonly known as employment certificates, working papers and special permits for agriculture, newspaper carriers or theatrical employment.

This course is now available for enrollment for the spring 2022 cohort (3rd of current school year); it will begin

March 17-18, 2022. The course must be completed by April 21, 2022. Enrollment is rolling through April 14, 2022.

Upon completion, participants will receive a certificate of completion for two PDUs. In addition, NJSS will work with NJLWD to return answers to any questions you put in the Rutgers Canvas LMS course evaluation by April 29, 2022 if you are in this 3rd cohort of the current school year.

C.) New: NJDOH Releases Safe School Chemical Management Resources

The New Jersey Department of Health (NJDOH) recently developed two new resources on safe chemical management in schools. These resources address the proper storage and disposal of hazardous chemicals in school science laboratories in relation to the NJ "Right to Know" law for workers and communities. The 1st booklet titled "<u>Safe Chemical Management in School Science Laboratories: Guidance for Teachers and</u> <u>School Administrators</u>" provides guidance to public schools on managing laboratory chemicals, including purchasing, storage, labeling, and disposal. The goal of this booklet (which is based on CDC/NIOSH's School Chemistry Laboratory Safety Guide) is to prompt teachers to evaluate their chemical inventory, reassess the hazards of the chemicals being used, and encourage proper disposal of unused or expired chemicals.

The 2nd booklet titled "<u>Safe Chemical Management in School Science Laboratories: Surveillance Findings</u>" describes the prevalence of hazardous chemicals in NJ public schools based on 2017 Right to Know Online Survey data. This resource illustrates how frequently NJ public schools reported chemicals identified by CDC/NIOSH as having a hazardous nature beyond justified use in K-12 education.

D.) New: ScreenNJ Art Contest for NJ High School Students

<u>ScreenNJ</u> is an initiative focused on increasing the awareness about the importance of cancer screening and improving screening rates across the state. Originally focused on colorectal cancer and lung cancer, which are among the most prevalent cancers in the state, ScreenNJ has recently expanded its efforts to also address breast cancer, skin cancer, prostate cancer, cancers related to family and genetic risk factors, and HPV (human papillomavirus)-related cancers such as cervical cancer. This expansion includes free access to cancer screening navigators who help individuals get screened and bring cancer screening services directly to communities.

ScreenNJ is inviting high school students across NJ to participate in a visual art competition to help visually communicate and celebrate the community-focused health promotion goals of the ScreenNJ program. This competition is open and accepting entries during March 2022 and winners will be announced in April 2022.

To support NJ school districts and schools re-opening local and county campuses, classrooms, gyms, laboratories and schops in August-September 2021 for in-person learning (general education, work-based learning, extracurricular activities, etc.), we wanted to remind our colleagues in administration and designated persons roles (facilities, operations and maintenance, Right to Know, etc.) of resources available online for free to assist walk-through assessments. Schools are now required by code (N.J.A.C. 6A:19-6.5) to submit their incident report online. You can also download a copy of the newly updated "Guidance Manual for Completing the Incident Reporting Form" on this site. Note: The Guidance Manual was updated as of December 2018.
