Definitions:

Mobile ladder stand means a manually propelled mobile fixed size self-supporting ladder consisting of a wide flat tread ladder in the form of stairs. The assembly may include handrails.

Rise means the vertical distance from the top of a tread to the top of the next higher tread.

Tread means the horizontal member of a step.
