MASTER OF PUBLIC HEALTH IN SOCIAL WORK AND PUBLIC HEALTH (MPH)

ABOUT

The Rutgers School of Social Work and Rutgers School of Public Health's Master of Public Health (MPH) in Social Work and Public Health degree, is a concentration specifically designated for Master of Social Work (MSW)/MPH dual-degree students to maximize credit sharing and leverage social work and public health. This dual-degree concentration offers advanced training opportunities for public service individuals, particularly social workers, that are dedicated to achieving health equity and overcoming health disparities in health care settings and systems.

This program, founded upon the intersection of public health and social welfare, prepares students to prevent, address, and resolve health problems at various levels, including the micro (individual/clinical), mezzo (family, organizational, or community), or macro (society or population) levels. Honing students' knowledge in urban health and social and behavioral sciences, graduates will become public health social workers that understand the intertwining individual, biological, social, economic, political, and environmental factors that critically influence treatment and health outcomes.

Graduates are eligible to sit for the Certified in Public Health Exam and apply for licensing in social work.

PROGRAM FORMAT

The MPH in Social Work and Public Health degree is offered to students on a full-time basis. The degree requirements may be completed in three years.

Students will complete a total of 72 credits, 42 credits of MSW coursework and 30 credits of MPH coursework, including a practicum experience and capstone research project. Courses are available in-person, remote, and/or online. tudents are also required to register for and complete an Interprofessional Education activity prior to graduation. Students can earn a post-baccalaureate certificate alongside their degree with an additional 6-12 credits. Contact admissions for additional information at admissions@sph.rutgers.edu.

APPLICATION REQUIREMENTS

Students interested in the MPH in Social Work and Public Health degree will be required to apply and be accepted to both the Rutgers School of Social Work and Rutgers School of Public Health separately.

A complete application includes:

- Online express application: visit go.rutgers.edu/sph-apply
- Official transcripts from all post-secondary institutions attended
- Statement of goals, one-to-three pages in length, which addresses:
 - o Interest in the program
 - Preparedness for the program
 - Goals and aspirations
- Two letters of recommendation with at least one letter from an academic reference if you are currently enrolled in a degree program or have graduated within the last four years
- Resume or CV
- GRE General Exam (optional)
- TOEFL or IELTS score for applicants educated in a non-native English-speaking country

Applications are accepted on a rolling, space-available basis following the regular deadline.
