



## PEOSH/NJADP - 2025-2026 - Indoor Air Quality Training Schedule

PEOSH has arranged to provide assistance to public employers in meeting the Designated Persons Training requirements contained in the PEOSH Indoor Air Quality Standard by scheduling these training sessions. This program also addresses the roles of the school nurse and the Indoor Air Quality Team in IAQ programs. Participants receive 4 Continuing Education Units (CEUs). Facilities Managers with CEFM certification should note that the 4 CEUs help fulfill the NJDOE requirement that 20 CEUs must be earned within a three-year period to maintain certification.
